

**7 DAY SUMMER SELFIE INSTAGRAM CHALLENGE CONTEST**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**THE 7 DAY SUMMER SELFIE INSTAGRAM CHALLENGE CONTEST (THE “CONTEST”) IS INTENDED FOR PARTICIPATION ONLY IN THE UNITED STATES AND SHALL BE CONSTRUED ACCORDING TO, AND GOVERNED EXCLUSIVELY BY, UNITED STATES LAW. By participating in the Contest, you unconditionally accept and agree to comply with and abide by these 7 Day Summer Selfie Instagram Challenge Official Rules (these “Official Rules”), the entry procedure for the Contest set forth on the Website (as defined in Section 3), the Terms of Use of the Website located at [HYPERLINK "http://www.sheknows.com/mediakit/articles/813565/terms-of-use-agreement-1"](http://www.sheknows.com/mediakit/articles/813565/terms-of-use-agreement-1) <http://www.sheknows.com/mediakit/articles/813565/terms-of-use-agreement-1> (the “Terms of Use”) and the decisions of Sponsor, which shall be final and binding in all respects. To the extent the Terms of Use and these Official Rules conflict, these Official Rules shall prevail.

Each daily photo submission (collectively, your “Submission”) must be publically viewable on Instagram and must comply with Instagram’s Terms of Use and Community Guidelines, in addition to these Official Rules, in order to be eligible and qualify for participation in the Contest. All photos included in a Submission will be deemed to have been submitted by the authorized account holder of the Instagram account from which the photos are uploaded at the time of submission, as identified by the primary email address associated with that account. In order for your Submission to be complete, your Submission must satisfy the submission requirements described in Section 4 and you must have submitted your Instagram account user name in as set forth on the Website. Incomplete Submissions, including, without limitation, those Submissions that do not meet the requirements set forth herein, will not be eligible for judging. Your Submission must be received no later than 11:59:59 PM PST on June 30, 2013. The Website’s database clock will be the official time keeper for the Contest. Proof that you uploaded an entry does not constitute proof that it was received or received during the Contest Period. Sponsor will only accept Submissions during the Contest Period. Furthermore, Sponsor shall have no liability for any Submission that is lost, intercepted or not received by Sponsor. **SUBMISSIONS:** The requirements for Submissions are as follows:

Each Submission must consist of at least one photograph uploaded each day between June 24, 2013 through June 30, 2013, accompanied with “#sk7day” and the applicable hashtag of the day set forth above.

The photographs included in the Submission must be in a digital format accepted by Instagram for upload.

Each Submission must be entirely your own work and must not contain any content that is obscene, pornographic, libelous or otherwise objectionable or inappropriate.

You may not submit any photograph or caption that contains any elements from any other artist’s creation, work or pieces.

Other than the Sponsor, its brands and/or logos, no Submission may show, contain, mention, depict, refer or otherwise allude to the name or logo of any retailer, manufacturer, brand, product, store, place of business, person, company or character in such a way or manner as to imply an affiliation with, or endorsement of, Sponsor or its brand.

The parent or legal guardian of any identifiable person under the age of majority in his/her state of residence appearing in a Submission must have consented to the Submission.

You agree that once you submit your Submission, it becomes the licensed property of Sponsor.

**JUDGING AND WINNER NOTIFICATION:** At the end of the Contest Period, the Submissions shall be judged by representatives of Sponsor, who will select one winner of the Contest from such Submissions based on the following criteria: (a) up to 10 points will be awarded for the completeness of the Submission; (b) up to 10 points will be awarded for the accuracy of the Submission to the stated daily photo themes set forth above; and (c) up to 80 points will be awarded based on the creativity of the Submission. In the event of a tie, the panel of judges will select the winning entry according to the judging criteria. The decision of the judges of the Contest on all matters related to the Contest and these Official Rules shall be final and binding. The potential winner of the Contest will be notified of potentially winning the Contest through Instagram or via email and must respond to Sponsor within 48 hours of Sponsor sending such notification, which response shall include the winner's mailing address, age, your first name, last name, address, phone number (including area code) and email address. In the event that the potential winner does not respond within such 48-hour period, or if the potential winner is otherwise ineligible or fails to complete the Prize Claim Documents (as defined below), Sponsor shall have the right, but not the obligation, to award the prize to the entrant whose Submission earned the next highest score. Sponsor reserves the right to request proof of these representations and warranties in a form acceptable to Sponsor from you at any time. By submitting a Submission, you represent and warrant that you and any persons appearing or who are identifiable in the Submission consents to the submission and use and exhibition of the Submission in the manner set forth in these Official Rules and the Terms of Use. Sponsor reserves the right to disqualify any Submission for any reason, in its sole and absolute discretion. Each entrant agrees to release, defend, indemnify and hold harmless each of the Sponsor Entities, those working on behalf of the Sponsor Entities and each of their respective officers, directors, managers, representatives, employees, agents, successors and assigns from any damage, injury, death, loss or other liability, either at law or equity, whether known or unknown, asserted or non-asserted, including reasonable attorneys fees, that may arise from or in any way relate to any entrant's participation in the Contest, entrant's breach of any representation, warranty or covenant set forth herein, Sponsor's use of the Submission or the awarding, acceptance, use or misuse of any prize.

**FURTHER DOCUMENTATION:** In the event Sponsor shall desire to secure additional assignments, releases, certificates of engagement for the Submission or other documents as Sponsor may reasonably require in order to effectuate the purposes and intents of the agreements hereunder, you agree to sign the same upon Sponsor's request therefor (without any need for any additional consideration).

**PUBLICITY RELEASE:** By participating in the Contest, in addition to any other grants which may be granted in any other agreement entered into between or among Sponsor and you, you irrevocably grant Sponsor and its successors, assigns and licensees, the right to use

your Submission, name, Instagram user name, likeness, biographical information, and the name, likeness and biographical information of any individual(s) participating in the Submission, in any and all media for any purpose, including without limitation, commercial, advertising and promotional purposes as well as in, on or in connection with the Website or the Contest or other promotions, and hereby release the Sponsor Entities from any liability with respect thereto, unless prohibited by law.

Finally, you acknowledge that, with respect to any claim by you relating to or arising out of any Sponsor Entities' actual or alleged exploitation or use of any Submission or other material submitted in connection with the Contest, the damage, if any, thereby caused to you will not be irreparable or otherwise sufficient to entitle you to seek injunctive or other equitable relief or in any way.

Any and all disputes, claims and causes of action arising out of or in connection with the Contest shall be resolved individually without resort to any form of class action.
